Challenge  Decision-making, introduction, revitalisation of the vaccine coverage	Description of Challenge  Please describe in more detail the challenge	Additional Comments
Poor buy-in from primary gatekeepers	Low acceptance from key influential community voices like religious leaders, traditional leaders, due to lack of information	
Inadequate inclusion of non-EPI stakeholders	Inclusion of non-EPI stakeholders like education, traditional and religious leaders was suboptimal	
Unavailability of funds to cover some ACSM activities	The VIG fund was inadequate to cover ACSM activities like media appearance and media airing due to inflation	
Suboptimal coordination processes at subnational	Coordination of HPV roll out at subnational level was suboptimal due to non-inclusion of non-EPI stakeholders and also due to competing priorities	
Political instability	Due to political instability and change in government a lot of key EPI and non-EPI stakeholder are changed thereby affecting stakeholder engagement and community mobilization	
Anti vaccination / sabotage from organisations	This was prevalent and mostly came from health workers discouraging people from getting their wards vaccinated	
Transition in Government	This led to new appointment of stakeholders and program officers who were already deeply involved in the HPV implementation
